AB 1507 (Logue) **Health care coverage.**

Bill Status: dead

Summary:

This bill would allow an individual or small employer health benefit plan in effect on October 1, 2013, that does not qualify as a grandfathered health plan under PPACA to be renewed until October 1, 2014, and to continue to be in force until December 31, 2014. The bill would exempt an individual or small employer health benefit plan in effect on October 1, 2013, that does not qualify as a grandfathered health plan under PPACA and that is renewed between January 1, 2014, and October 1, 2014, from various provisions of state law that implement the PPACA reforms described above.

Summary:

The act of dissolving the nonprofit corporation and abating unpaid taxes, interest, and penalties serves a statewide public purpose by ensuring that nonprofit corporations that have been suspended or forfeited tax exempt status are no longer able to do business in the state, which will relieve the citizens of California from unknowingly donating to a nonprofit corporation that is not complying with the laws of the state,

Summary:

This bill would require a client employer to share with a labor contractor all civil legal responsibility and civil liability for all workers supplied by that labor contractor for the payment of wages and the failure to obtain valid workers' compensation coverage. The bill would prohibit a client employer from shifting to the labor contractor legal duties or liabilities under workplace safety provisions with respect to workers provided by the labor contractor.

An employer with 50 or more employees shall provide at least 2 hours of classroom or other effective interactive training an education re: sexual harassment to all supervisory employees in CA once every 2 years.

This bill would prohibit an employee from receiving an award of costs and reasonable attorney's fees if the employer is the prevailing party and the court determines that the action was brought in bad faith, in which case the bill would require the employer to be awarded attorney's fees and costs.

This bill would instead require those corporations, limited liability companies, and credit unions to file the statement with the Secretary of State during the calendar month of, or within the 5 months preceding, the organization's due date for filing its return, excluding extensions, with the Franchise Tax Board or if no return is required, by May 15, as provided.

Summary:

This measure would request that the President of the United States encourage, and that the Secretary of the United States Department of Health and Human Services adopt, policies that repeal the current donor suitability policies of the federal Food and Drug Administration regarding the donation of blood by men who have had sex with another man.

SB 935 (Leno) **Minimum wage: annual adjustment.**

This bill would increase the minimum wage, on and after January 1, 2015, to not less than \$11 per hour, on and after January 1, 2016, to not less than \$12 per hour, and on and after January 1, 2017, to not less than \$13 per hour.

SB 1011 (Monning) **Nonprofit corporations: self-insurance.**

This bill would extend provisions to authorize the establishment of an insurance pool to self-insure against the loss or damage to property of every kind, including, but not limited to, losses and expenses related to the loss of property.

SB 1204 (Lara) California Clean Truck, Bus, and Off-Road Vehicle and Equipment Technology Program.

Summary:

This bill would create the California Clean Truck and Bus Program, to be funded from cap and trade revenues, to fund zero- and near-zero emission truck and zero-emission bus technology and related projects, as specified, with preference to be given to projects in disadvantaged communities. The program would be administered by the state board.

SB 1207 (Wolk) California Voluntary Contribution Program.

Summary:

This bill would modify the existing voluntary check-off system by establishing the California Voluntary Contribution Program to expand the contribution options for a taxpayer. Commencing January 1, 2016, the bill would establish the Office of California Volunteers to administer the program. The bill would provide that the purpose of the program is to promote charitable giving and collect through the personal income tax return individual taxpayers' voluntary contributions to qualified applicants, defined to include any charitable organization or a state or local agency meeting certain requirements.

SB 1301 (DeSaulnier) Corporate Flexibility Act of 2011: Social Purpose Corporations Act.

Summary:

The Corporate Flexibility Act of 2011 authorizes and regulates the formation and operation of flexible purpose corporations.

This bill would rename the act as the Socially Responsible Corporations Act and rename the type of corporation authorized and regulated under that act as a socially responsible corporation.

Notes:

similar to AB 361 (Benefit **corporations**) and SB 201 (**Flexible purpose corporations**). we opposed SB 201
